1. A purebred Boxer puppy eligible for **full registration** with the American Kennel Club (AKC).

A NON-REFUNDABLE deposit of \$250.00 is required to hold your Boxer puppy.

2. The Seller will register the litter with the American Kennel Club (AKC), litter # **WS348576**, and provide the registration application to the Buyer. The Buyer is responsible for registering their puppy.

3. The Seller guarantees that the puppy is in good health on the date of shipping or pick up. The Buyer has the right to return the puppy to the Seller within **three** days after delivery and receive a refund of the purchase price if the puppy is found by a licensed veterinarian to be suffering from any pre-existing disease.

4. The Buyer shall maintain the puppy in good condition, including adherence to a regular immunization schedule, heartworm preventative, good diet appropriate to age and activity, and a clean and safe environment.

5. If at any time in its life, the puppy is to be sold or given away, the Buyer shall so notify the Seller and give the Seller first option to buy the puppy back at the original purchase price.

6. The BUYER understands that the deposit to hold a puppy is NON-REFUNDABLE unless the puppy you held is not healthy enough to sell (see # 3 above). In that case, deposits may be returned or applied to the next available or closest breeding to the one originally planned. If you change your mind about getting a pup, or you are unable to fulfill your financial obligation to get the pup once the deposit is paid, the deposit will be forfeit to cover the expenses of food, vaccinations, etc. of the pup during its extended stay at PS Boxers.

7. SHIPPING: Shipping is not included in the price of the puppy. Shipping anywhere in the US is \$\_\_\_\_\_ on Delta or Northwest this includes airline crate, health certificate and airline ticket. Puppy must be shipped directly to airport for immediate pick up. Please call for shipping quote.
